# **Diversity, Equity, and Inclusion Development**

## **Opportunity for Nonprofits in West Central Illinois**

The Tracy Family Foundation wants to help nonprofit organizations and schools become more effective by providing a customized Diversity, Equity, and Inclusion (DEI) Development and Coaching. The Tracy Family Foundation is issuing a Request for Proposal (RFP) to organizations for \$5,000 which requires a 10% matching contribution (\$500), totaling \$5,500 for the experience. Nonprofit and educational organizations serving west central Illinois in the counties of Adams, Brown, Cass, Greene, Hancock, McDonough, Morgan, Pike, Scott, and Schuyler are eligible to submit a proposal.

### What is DEI?

*Diversity* is the presence of differences that may include race, gender, religion, sexual orientation, ethnicity, nationality, socioeconomic status, language, (dis)ability, age, religious commitment, or political perspective.

*Equity* is promoting justice, impartiality, and fairness within the procedures, processes, and distribution of resources by institutions, organizations, or systems.

*Inclusion* is an outcome to ensure those that are diverse feel welcome. Inclusion outcomes are met when you, your organization, and your program are truly inviting to all.

## **Program Description**

The DEI Customized Coaching and Training program intends to help leaders thoughtfully evaluate and successfully implement Diversity, Equity, and Inclusion practices in their organizations. The program will help participants assess their current DEI policies and practices, reflect upon strengths and concerns, and ultimately help organizations strengthen their existing DEI practices through coaching and training as needed. It will work with leaders and Boards to explore existing practices and to develop practical strategies for their organization. The customized coaching and training sessions will be identified and completed with your DEI coach. You and your DEI coach will determine meeting dates and times.

- ✓ Does the organization...
  - 1. demonstrate a commitment for organization leaders to attend and fully participate in all sessions of the Diversity, Equity, and Inclusion Development series?
  - 2. demonstrate board support and commitment by resolution to honestly assess the organization's DEI progress?
  - 3. demonstrate a commitment from leaders, board, and other stakeholders to implement a DEI action plan?

#### How to Apply

The Diversity, Equity, and Inclusion Development Request for Proposal is an on-demand application, meaning organizations may apply anytime throughout the year. Applications are reviewed on a rolling basis.
